#### Mural at 4750 N. Sheridan to honor saint

A mural created for a former tenant will be getting moved from 4750 N. Sheridan, but for a very good reason. The subject of the mural has just been canonized as a saint.

Colleague Paul Noah painted the mural of Kateri

Tekakwitha for the Anawim Center, the Native American outreach program of the Archdiocese of Chicago. Once housed at 4750 N. Sheridan, the Center has moved to the St. Benedict Church Campus and been renamed the Kateri Center of Chicago after Kateri Tekakwitha, one of the first Native Americans to convert to Christianity.

The Roman Catholic Church announced on Feb. 18 that Kateri has been canonized as a saint, one of the first Native Americans so honored, said Georgina Roy, director of the Kateri Center. The mural at 4750 N. Sheridan will be the image of the new saint in holy cards that will be distributed to churches across the country.

Arrangements are being made to move the mural with minimal damage to a new shrine for Kateri at St. Benedict. Georgina stated that the center is just waiting for confirmation of plans from the contractors who will be transporting the mural before setting a date for the move. She added that everyone will be welcome to visit the artwork in its new home.

The colleges and universities with students and classes participating include DePaul University, Chicago State University, Roosevelt University, Northeastern Illinois

University, Loyola University Chicago, University of Illinois-Chicago and St. Xavier University.

Nina Winn, Resilient Communities program coordinator, said that the students are coming from a variety of disciplines including journalism, geography and sociology. She added that as of late February, there were an estimated 179 students who have been active in the research. ICA and university partners are also developing a social media tool to allow for communication between individuals and organizations. The project will culminate in a "Sharing Approaches That Work" (SATW) conference on September 15, 2012.

## **ToP Elects New Board Members at Meeting**

Trainers of ICA's Technology of Participation (ToP)® met in Sacramento, CA for their annual conference. More than 90 people from across the country were in attendance with at least a third attending their first conference.

The network has 50 public Facilitation Methods sessions and 21 Strategic Planning courses scheduled for the remainder of 2012. There are 20 advanced courses scheduled for 2012.
